CM Lumm,

To answer your questions:

- 1. The request for this came from the merchants associations via the DDA, so my understanding is that they are supportive.
- 2. I don't think there are solid plans for what a program like this might look like in 2021, and I would shy away from saying that there are plans to permanently change the streets. I think the idea is to just do a pilot and see how it goes, and if it is successful then take those lessons forward to a potential program in 2021. But we will of course put feedback from the public and merchants associations front and center in forming any kind of plan.
- 3. The intention was to include all meter parking spaces. In addition a business could only use a space that is adjacent to their store front for outdoor service under the MLCC, so a bar or restaurant couldn't open a random pop-up table in the middle of a neighborhood, for instance. Similarly, all of these closures would be handled through a sidewalk extension permit, which requires the "extension" to also be adjacent to the business. So any meter space that doesn't have a business in front of it wouldn't be eligible for this extension. The map included in the power point simply shows where all of our metered spaces are, but that does not mean that all of these spaces are eligible for and outdoor service or for a sidewalk extension permit. That should absolve any issue where a street that is fundamentally a neighborhood street, rather than a business district street, might be included in the program.

Do these answers help? I am happy to answer any follow ups.

No offense Mr. Mayor :- ), your statement that, "none has identified cautions that in my view warrant delay", is "your view" and I would prefer that they "speak for themselves". With regard to the 3<sup>rd</sup> resolve clause, I will just share that I believe that to protect our community we must have sworn police officers who are trained and equipped to use force if/when appropriately required. I do not see social workers taking on this kind of work and question whether Community Mental Health outreach social workers would be comfortable being the first to respond (they want and rely upon AAPD to analyze calls and respond first, and then assist on calls as appropriate). I know the defund movement seeks to replace sworn officers with social workers, and why this resolve clause, as worded, concerns me. We have a system in place that utilizes social workers, but it is my understanding they will not, understandably, answer calls without that AAPD assessment and frontline/first to respond assistance.

Mr. Crawford,

I request that the Admin. Cte. take up the issue of agenda setting -- an issue we've not addressed for sometime, initially, because it seemed rather "academic" (after the upcoming agenda was prepared/assembled and/or the agenda more or less comported with normal protocol -- items (staff and council) were submitted on time), etc.), but should do so now because, in my opinion, this is no longer the case. This ordinance change, a significant ordinance amendment, submitted at 6:30 pm., Friday evening, after the agenda is published, and 2+ days after the deadline for submittal of agenda questions is an Exhibit A of what is unacceptably poor process.

Lately there have been issues raised about the length of council meetings. I have observed a direct correlation between the length of meetings and the # of questions asked about agenda items AT our meetings. Yes, it is on us to submit our questions in advance, but, for Monday's meeting, this late item, plus nine other rather significant items were added yesterday. Yesterday. Including one item (the ICPOC resolution) that was sprung onto the agenda, with a just after midnight Fri. am. "heads-up" from the Mayor afforded CM Ramlawi and myself. That's not close to OK. (Council, CM Ramlawi and I asked for time to seek and offer input after we rec'd. in the wee hours of Fri. a.m., but our requests were rejected by the sponsors. No other way to put it.)

The public hearings need to be better coordinated and planned (seeing too many public hearings on important issues scheduled for the same agenda), staff needs to comply with their own deadlines (which would allow for council to submit questions in advance), and the Mayor and council need to demonstrate the same regard for deadlines.

Guess you could say Mr. McDonald's late submission tipped the scale for me -- the proverbial "straw".

I fully anticipate a long meeting on Monday, and hope all CM's feel it is appropriate to ask their questions at the meeting -- no holds barred. CM's need to be permitted to do their "jobs",

Thank you for listening, and I look forward to discussing this at the next Administration Cte. meeting. I welcome any and all input from council and staff.





Thank you for your and CM Grand's work on this and for providing this to CM Ramlawi and me. It is well-written and clearly ICPOC is the proper organization/mechanism to conduct a review like this.

It is likely I will add my name, however, before I do that I would like to hear from Mr. Crawford, Mr. Postema, and, most especially, Chief Cox. No offense Mr. Mayor :- ), your statement that, "none has identified cautions that in my view warrant delay", is "your view" and I would prefer that they "speak for themselves". I'm also interested in CM Ramlawi's views.

With regard to the 3<sup>rd</sup> resolve clause, I will just share that I believe that to protect our community we must have sworn police officers who are trained and equipped to use force if/when appropriately required. I do not see social workers taking on this kind of work and question whether Community Mental Health outreach social workers would be comfortable being the first to respond (they want and rely upon AAPD to analyze calls and respond first, and then assist on calls as appropriate). I know the defund movement seeks to replace sworn officers with social workers, and why this resolve clause, as worded, concerns me. We have a system in place that utilizes social workers, but it is my understanding they will not, understandably, answer calls without that AAPD assessment and frontline/first to respond assistance.

I understand that we all have feelings on how this went down. I hear you that you didn't believe the 'morning of' notice and invitation to be collaborative, but rather felt that it was intended to be pressure and not genuine. I see that position and own that I didn't appreciate or recognize that I was making a difficult ask. My apologies. For my part, I was scrambling all week to get together a document and concept with which I was satisfied (and that passed some level of staff and ICPOC leadership scrutiny) and that met the national and local demand for thoughtful yet urgent engagement on this incredibly important issue. When the conversation moved swiftly from "it is likely that I will add my name" and "I hope that with additional time and better understanding . . . I can become a co sponsor" to communications of a sharply different tone after I didn't express support for withdrawing it from the agenda, I declined to further engage.

Moving on, I continue to think that it is important to have this item on the Agenda today due to the urgency of the issue, but as I said on Friday, I don't have a strong opinion that it needs a vote today.
