

**MAYOR PRO TEM LUMM:** Are there any communications from council?

**COUNCILMEMBER RAMLAWI:** Councilmember Hayner would like to speak.

**MAYOR PRO TEM LUMM:** Okay. I'm going to take them in the order, but since Councilmember Hayner, you are traveling, I will call on you first. Councilmember Hayner.

**COUNCILMEMBER HAYNER:** Thank you, Mayor Pro Tem. So just, you know, since there's been so much – so many false narratives put forward prior to this election, even tonight some of these callers are calling in – I never suggested that we should shut off water and power. I pointed out that Governor Newsom of liberal California said he was going to do that to house parties and that we shouldn't consider doing that here – that we shouldn't consider doing that here. I don't think anybody would really think that that was a solution to anything.

I've spent my last two years fighting for water for this community, fighting for renters, trying to get some affordable housing going. Nothing's happened for years in this community until we got on here. And now we get some affordable housing going, some rights, some tenant activism and things like that. That's great. I support that. Don't put words in my mouth. Go back and listen to what I said. I never said we should shut off power and water to houses. That's how lies get started. That's how people grab stuff and they put it on a postcard and they send it out.

Now to Mr. Magiera, same for you. You're so hot to keep everybody's data in front of everybody, you, your buddies and you have (inaudible) all my social media and post it somewhere. Let me ask you to do something for the community. Do the same thing for MLive, where people who don't want to pay to see political coverage – copy those MLive stories and post them out there for somebody. How about that, okay? Keep the real story in front of people. That would go a long way towards helping this community, instead of coming on here and complaining about how I speak to the Mayor, who hasn't answered one of my emails in two years – look after your own business and do something else for the community, all right? I would really appreciate that.

I just think it's (inaudible) folks who are – the – I mean, I'm just going to be frank. Mr. Mayor is pulling the strings of these people. He's using these people to spread these – to put words in our mouths and to say false things about us. They're all your supporters. Go around and look at the yard signs in their yards. Mr. Mayor, it's time for you to rein people in, if you want to have any hope of having any legacy of decency in that seat. And I'll talk to you however I want.

**COUNCILMEMBER SMITH:** That's uncalled for. Uncalled for.

**COUNCILMEMBER HAYNER:** I will talk to Mr. Mayor however I choose.

**COUNCILMEMBER ACKERMAN:** Do we have council rules about ad hominem attacks?

**COUNCILMEMBER SMITH:** We do. I will be bringing this up with the Rules Committee.

**MAYOR PRO TEM LUMM:** And if I could --

**COUNCILMEMBER HAYNER:** Yeah. Also, while you're there – while you're there, bring up the Mayor using his private email address.

**MAYOR PRO TEM LUMM:** Excuse me.
