Dear Ryan Stanton:

Your request as to all complaints against AAPD received/reviewed by the city's police oversight commission since its inception is granted in part and denied in part. It is denied to the extent that redactions of names of complainants and officers, as well as personal contact information were made pursuant to MCL 15.243(1)(a): Information of a personal nature if public disclosure of the information would constitute a clearly unwarranted invasion of an individual's privacy.

Your request as to final reports from AAPD to the commission regarding findings of investigations into those complaints is granted.

Your request as to commission reports containing the commission's conclusions regarding those incidents is denied to the extent they do not exist.

Your request as to any and all records of discipline against AAPD officers stemming from complaints received/reviewed by the city's police oversight commission is denied pursuant to MCL 15.243(1)(s)(ix): information that would disclose personnel records of law enforcement agencies.

Your request as to any and all AAPD correspondence with the prosecutor's office on any incidents that were considered for charges against an officer is denied to the extent they do not exist.

If you receive written notice that all or a portion of your request has been denied, then under Sec. 10 of the Freedom of Information Act (FOIA) and Sec. 16 of the City's FOIA Procedures and Guidelines you may, at your option, either 1) submit to the City Administrator, within 180 days of the date of this response, a written appeal that specifically states the word "appeal" and identifies the reason(s) for reversal of the denial; or 2) commence a civil action in the Washtenaw County Circuit Court to compel the City's disclosure of the record. If, after judicial review, the circuit court determines that the City has not complied with the Act and orders disclosure of all or a portion of a public record, you may be awarded reasonable attorney's fees and damages as specified under the FOIA.
