Re: E. Stadium Blvd. Bridges Replacement Project
Upcoming Golden Avenue Traffic Change

Dear Resident:

We are writing to inform you of an upcoming temporary change in traffic patterns in your area. As part of the E. Stadium Blvd. Bridges Replacement Project, Golden Ave. between Granger St. and E. Stadium Blvd. will be temporarily changed to allow two-way traffic for **BUSSES ONLY**. This change will occur between November 28, 2011 and December 13, 2011. All other vehicle traffic will continue to be allowed to travel northbound only on Golden Ave.

This change is necessary in order to accommodate Ann Arbor Transit Authority (AATA) buses while S. State St. is temporarily closed as part of the subject project. AATA buses will be permitted to travel northbound and southbound along Golden Ave. between November 28, 2011 and December 13, 2011.

A vehicular detour route will be in-place while S. State St. is temporarily closed. In order to encourage vehicles to use the posted detour route, barricades and "Road Closed to Thru Traffic" signs will be installed at the following locations:

E. Stadium Blvd. intersections at: Henry St., Golden Ave., Westminster Place, Ferndale Place and Montclair Place
Packard St. intersections at: Granger Ave., Dewey Ave. and McKinley Ave.
S. State St. intersections at: Granger Ave., Dewey Ave. and McKinley Ave.
A full closure is also in place on Rose Ave. between S. State St. and White St.

We are working closely with the Police in order to implement these plans. We will also monitor detour routes to determine possible improvements and/or adjustments.

In order to minimize the number of vehicles traveling through the residential area along Golden Ave. **ONLY BUSSES** will be permitted to travel southbound. All other vehicles will be permitted to travel northbound only on Golden Ave.

Parking along the west side of Golden Ave. will also need to be temporarily prohibited for this two week period. "No Parking" signs will be installed along the west side of Golden Ave. **Golden Ave. traffic will be returned to its current configuration on December 14, 2011.**
