- Information of a personal nature if public disclosure of the information would constitute a clearly unwarranted invasion of an individual's privacy. MCL 15.243(1)(a)
- 2. Information or records subject to the attorney-client privilege. MCL 15.243(1)(g)

Pursuant to your request, electronic communications initiated by the City Attorney's Office have not been provided; however, there are electronic communications sent to and from City Council members that include members of the City Attorney's Office, which have been redacted. Additionally, in the instance where a chain of emails occurred, the most complete chain was provided.

The City does not warrant or guarantee the accuracy of the information provided. Rather, it provides the documents only to comply in good faith with the Michigan Freedom of Information Act, and not for any other purpose.

If you receive written notice that your request has been denied, in whole or in part, under Section

10 of the Act, you may, at your option either: (1) submit to the City Administrator a written appeal that specifically states the word "appeal" and identifies the reason(s) for reversal of the disclosure denial; or (2) file a lawsuit in the circuit court to compel the City's disclosure of the record. If after judicial review, the circuit court determines that the City has not complied with the Act, you may be awarded reasonable attorneys' fees and damages as specified under the Act.



Dear Mayor Hieftje:

I was distressed to learn that a local Topeka hate group has announced that they intend to picket the funeral of Lance Corporal Minhee Kim at Covenant Presbyterian Church at 6 p.m. on Thursday (see http://www.godhatesfags.com/fliers/nov2006/20061107 minhee-kim-funeral.pdf). Please understand they are not representative of our community and we disavow in the strongest possible terms the hatred they espouse and their abominable activities.

For some perspective the group is led by Mr. Fred Phelps, a lawyer who was disbarred in our state courts in 1979 and in our federal courts in 1989, shortly before he began his 15 year demonstrations to gain attention for himself and his family. He holds himself out as a minister with the shakiest of credentials and a church made up primarily of those related to him by blood and marriage. Some have described it as a cult. Initially their ostensible reason for picketing was to attack homosexuals. Over the years the message has become just generalized hatred and the tactic of picketing is an attempt to arouse and anger members of the community, carrying signs that say such things as "Thank God For the Tsunami," "Thank God For 911," "Thank God for IED's" and now regrettably focusing on the pain in your community. In our state we have passed a funeral picketing statute and in our city we have an ordinance to protect religious services. This is a group that exploits their First Amendment rights to express hate and cause pain and we disavow them.

I write this letter out of a sense of profound embarrassment for our city.

I understand Mr. Wallace has been in contact with you regarding his disappointment that ADP was not selected in the recent RFP for HR software and support. I'd like to provide you with some background so you're fully aware of why the City chose Ultimate instead.

First of all, you should be aware that the selection team was truly a cross organization team. It was comprised of HR, IT, Finance, operating managers, timekeepers, plant representatives, parks, the district court, police, fire, payroll, and finance. This system is one of a few major systems the City uses so it was evaluated from many perspectives.

I think City staff came into the RFP process with high hopes for ADP since they're a nationally know name and they have a local presence. However, as you're aware we're making a strong attempt to acquire technology that supports our strategic direction and their product was just not consistent with our goals. The City is desireous of integrated, web-based, SQL based, low maintenance implementation. Some of the reasons Ultimate was selected over ADP were:

- + Ultimate responded with a hosted solution, which means the program runs on their computers and software updates are automatically performed by them. ADP responded with a 6-7 step payroll process for staff to follow with the software on our system.
- + Timekeeping is a big issue for the City. ADPs product was complex and not much improved over our present system.
- + ADP's product consists of numerous modules so you purchase just the pieces you want. However, the modules were not well integrated. For example, the report writing software is limited and is not integrated across the suite.
- + The general ledger interface did not meet the level of detail we needed to work with our other systems.
- + The recruiting and "on-boarding" of employees was not fully integrated with payroll (requires double entry).

Having said all this, ADP has a very good product. The problem we faced is the City has several pain-points with the present system that needs to be fixed. ADP's solution just wasn't the best fit in the areas we need improvement.

Good Morning,

I have few questions regarding private fencing, premits and drive way obstruction. This is the issue:

We've resided at Ann Arbor for over fifty years. We are having a problem with a current construction of fence in the middle of in the only shared drive way of 50 + years. Currently our new neighbor is constructing a fence which is obstructing our safe and past use. I've (Linda Sen) phoned Mathew Kowalski, Ann Arbor Zoning Dept. to obtain information on the guidelines regarding this issue. Concerning, the neighbor admitted to my brother and I, they had been intentionally parking in order to block our use. Neighbor's intention was to discover how much driveway we needed in their opinion. On several occasions my sister could not park in our backyard the during early morning hours due to their greedy procedures. Instead, she parked on another street and walked the distance home. (This was to prevent an exploding this issue.) During a discussion which became heated we were threaten with their intention by this statement "or we'll really mess with you by completing this fence to totally blocking your use of the driveway and more?" Completing statement," so, let's better be good neighbors".

I've called Mathew Kowalski, City of Ann Arbor Zoning Department for direction / information to file a compliant. He stated the following:

1. We would have to prove easement right by going down to Register Deeds and searching through all the records to find the easement rights to a drive way, only then, would he step in. Including he stated, there are no such records recorded at the Register of Deeds for the older homes in the neighborhood. However, this search, we am current doing but will take sometime to complete due to the age of the home.

Question: Shouldn't this search / information be completed by the city before permits are issue or was it, seemly how this is such an on going issue?

Question: Again, I understand from Mr. Kowalski homes were designed at that time with shared driveways so why then isn't that currently being supported / honored by the City of Ann Arbor?

2. Further stated by Mr. Kowalski, this is quite an issue because it happens quite a bit in older neighborhoods. Again stating, there was nothing no one could do about it because in the past there were no easements filed in place when the dwellings were built. In short, we are then only victims and we don't have any rights over the issue regardless.

Needless to say, this is a very disturbing and very an uncomfortable situation that needs to be address for all residents in Ann Arbor.
