

Summary of Material Modifications to Regents Ordinance

The following is a high-level summary of the proposed changes to the Regents Ordinance.

1. **Geographic Scope (Article I. Section 1.)**. The revised ordinance expands the geographic scope covered by the ordinances to property owned or controlled by the Regents of the University of Michigan, including references to the Dearborn and Flint campus and any other University owned land within the State of Michigan.
2. **Parking (Article 2)**. The revised ordinance grants authority to the EVPCFO (for Ann Arbor) and the Chancellor or designee (for Dearborn and Flint) to designate and restrict parking lots and structures and issue parking permits. Rates are no longer specified in the ordinances, but will be listed online on the Logistics, Transportation and Parking website.
3. **Moving Violations**. The revised ordinance removes a significant number of redundant, non-specific to the University campus, moving violation ordinances. The ordinances that remain are generally specific to the University's campus and are related to traffic.
4. **Campus Park Spaces (Article IV)**. The ordinance is revised to make the provisions regarding campus park spaces more generally applicable. They are no longer solely specific to the Arboretum, but also include other campus park spaces generally.
5. **Alcohol Possession and Consumption (Article V)**. The revised ordinance prohibits alcohol consumption at athletic facilities or events unless expressly authorized by the EVPCFO, Executive Director of DPSS or Chancellors of Dearborn or Flint.
6. **Conduct at Athletic Events (Article VI) and Entry to Athletic Facilities (Article VII)**. The revised ordinance restricts crowdsurfing and increases the penalties for unlawful entry to the playing area (e.g., football field or basketball court) and unauthorized entry to an athletic venue or athletic facilities.
7. **Electric Scooters, Hoverboards, etc. (Article VIII)**. The revised ordinance adds regulations for the safe use of electric scooters and similar vehicles.
8. **Weapons (Article X)**. The revised ordinance adds an exception to the weapons prohibition for retired/active LEOs, individuals seeking medical treatment who are qualified to carry under Michigan law, and individuals qualified under Michigan law to carry and who are traveling across University owned-streets. The revised ordinance prohibits the use of University 3D printers to manufacture firearms or ammunition.
9. **Identification Cards (Article XI)**. The revised ordinance addresses the misuse or unauthorized transfer of identification cards.
10. **Disorderly Conduct (Article XII)**. The revised ordinance (a) removes the telephone related infractions from disorderly conduct; (b) adds ignited stick related infractions; (c) prohibits resisting/obstruction of police officer order; (d) prohibits wearing a mask or

disguise with intent to intimidate; and (f) and authorizes the University to prohibit bags in certain designated areas.

- 11. Fire and Life Safety (Article XIII).** The revised ordinance now includes fire related prohibitions (e.g., tampering with fire safety devices, overcrowding, open flames, obstructing exits, tampering with emergency blue light phones, etc.).
- 12. Animals (Article XIV).** The revised ordinance now includes certain carveouts for certain prohibitions to animals on campus to address service and similar animals.
