WHEREAS, the Washtenaw County Sheriff's Office will proactively work in partnership with Washtenaw County Administration, individual community members, advocacy groups, governmental entities, and other committed stakeholders, to implement fair, equitable and just public policies and practices; and

WHEREAS, this matter has been reviewed by the County Administrator's Office, Budget Office, Finance Department, Human Resources and Corporation Counsel.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby creates two 9-1-1 supervisory positions in the Emergency Services Division Metro Dispatch Center of the Washtenaw County Sheriff's Office.

BE IT FURTHER RESOLVED that the Washtenaw County Board of Commissioners authorizes amending the budget as attached hereto.
