WHEREAS, the Department of State Police Michigan Office of Highway Safety Planning (OHSP) announced July 30, 2023, that the Washtenaw County Sheriff's Office was eligible to apply to the Secondary Road Patrol and Traffic Accident Prevention Program (SRP) grant for FY24; and

WHEREAS, the Sheriff's Office has participated in this program for several years; and

WHEREAS, the Sheriff's Office wishes to continue this enhanced delivery of law enforcement services to the community; and

WHEREAS, the Washtenaw County Sheriff's Office applied for a grant award from the State of Michigan, Office of Highway Safety Planning, for funding in the amount of \$307,518.00 being made available through the state of Michigan Department of State Police; and

WHEREAS, this grant does not fulfill the total cost required to fund two Deputies for services, personnel costs, or automotive expenses to continue to deliver superior service for Secondary Road Patrol and the Traffic Accident Prevention Program: and

WHEREAS this grant will be supplemented by a revenue contract (R1485) between the Sheriff's Office and the Washtenaw County Parks & Rec Commission and the general budget to meet the full cost of one Deputy.

WHEREAS, this matter has been reviewed by Corporation Counsel, the Finance Department, Human Resources, the County Administrator, Facilities Management, Information Technology, Racial Equity Office, and the Board of Commissioners.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the signature of the Chair of the Board of Commissioners on the application to the Michigan State Police-Office of Highway Safety Planning for grant funding in the amount of \$307,518.00 through the Secondary Road Patrol and Traffic Accident Prevention Program Grant.

BE IT FURTHER RESOLVED that the Board of Commissioners takes the following actions contingent upon receipt of the grant award in conformity with the grant application:

1. Authorizing the Administrator to sign the Notice of Grant Award.

- 2. Amending the budget, as attached hereto and made a part hereof.
- 3. Authorizing the Administrator to sign the delegate contracts in conformity with the application/award upon review of Corporation Counsel, to be filed with the County Clerk.
