Dear Mr. Hays,

Washtenaw County wishes to amend the contract with your agency. Corporate Counsel has indicated that this amendment could be accomplished by a letter signed by both of us. If this amendment is agreeable to you, please sign and return this letter. You will receive an executed copy of this letter upon completion.

Accordingly, I hereby amend the Service Contract between Washtenaw County and Judicial Services Group dated June 15, 2021, as follows:

Amend ARTICLE II – COMPENSATION to reflect as follows:

Upon completion of services in the original contract WSCO Community Corrections will exclusively be utilizing Judicial Services Group for all electronic monitoring and will be billed monthly as outlined in "Attachment A". JSG will also be providing a dedicated staff member assigned to the Sheriff's Office at no additional charge. Based on the volume of electronic devices the monthly invoices vary based on the maintenance, monitoring and downloads hence making this a limitless contract.

Amend ARTICLE IV – TERM to extend the contract as follows:

This amendment is to extend the term for a one (1) year period which begins June 15, 2022 and ends on June 14, 2023.

All other terms and conditions remain the same as in the original contract, subsequent amendments and any applicable RFP/RFQ.





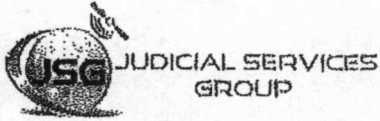
