Accordingly, I hereby amend the Service Contract between Washtenaw County and Judicial Services Group dated, June 15, 2021, as follows

Amend ARTICLE II – Compensation to amend the contract as follows.

Upon completion of the services in the original contract WCSO Community Corrections will exclusively be utilizing Judicial Services Group for all electronic monitoring and will be billed monthly as outlined in "Attachment A" JSG is also providing a dedicated Staff member assigned to the Sheriff's Office at no additional charge Based on the volume of electronic devices the monthly invoices may vary based on the maintenance, monitoring and downloads hence making it a limitless contract

Amend ARTICLE IV – TERM to extend the contract as follows

This contract shall be in full force and effect for the term of June 15, 2023, through June 14, 2024

All other terms and conditions remain the same as in the original contract, subsequent amendments and any applicable RFP/RFQ




