FIFTH AMENDMENT TO THE PROFESSIONAL SERVICE CONTRACT (Effective January 1, 2023)

This Fifth Amendment, effective January 1, 2023 (this "Amendment"), to the Professional Service Contract, dated December 9, 2014 (the "Agreement") is by and between Wellpath LLC ("Contractor") and Washtenaw, Michigan ("County").

WHEREAS, the Partiers agree to renew the Agreement; and

WHEREAS, the Parties agree to change to a cost-plus management fee model; and

WHEREAS, the Parties have determined that it is necessary and in the best interest of Covered Persons to remove eight (8) RN house from the day weekend shift and add 56 LPN hours to the day shift and 56 LPN hours to the evening shift for a total increase of 2.6 FTEs to the Agreement; and

WHEREAS, the Parties desire to amend the Agreement to memorialize such changes.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. **RECITALS.** The Parties hereto incorporate the foregoing recitals as a material portion of this Amendment.
- 2. **AMENDMENT TO ARTICLE II OF THE AGREEMENT.** The Agreement shall be amended deleting the current Article II in its entirety and inserting the following language in lieu thereof:

January 1, 2023 to December 31, 2023 ANNUAL AMOUNT. The base annual amount to be paid by the County to Contractor under this Agreement is Two Million Three Hundred Ninety Thousand Eight Hundred Thirty One and Forty Eight Cents (\$2,390,831.48) with \$2,115,831.48 for estimated direct expenses and \$275,000 for management fee, for a period of 12 months, payable in equal monthly installments. Each monthly installment shall be pro-rated for any partial months and subject to any reconciliations as set forth below. Each monthly installment is to be paid to Contractor on or before the 1st day of the month of service

ADJUSTMENT FOR COSTS IN EXCESS OF OPERATING BUDGET AMOUNTS. The quarterly reconciliation shall include any amounts paid by County in excess of or lesser than the actual expenditures of Contractor. If the expenditures exceed the monthly estimate, the County shall reimburse Contractor the difference. If the expenditures are lower than the monthly estimate, Contractor will credit the County the difference.

3. **AMENDMENT TO ARTICLE IV OF THE AGREEMENT.** The Agreement shall be amended by adding the following language to Article IV:

This contract shall be extended by remaining in effect from January 1, 2023 to December 31, 2023.

- 4. **AMENDMENT TO EXHIBIT D OF THE AGREEMENT.** The Parties agree that the Staffing Matrix attached hereto as Exhibit D-1 shall replace the previous Staffing Matrix incorporated into the Agreement.
- 5. **SEVERABILITY.** If any terms or provisions of this Amendment or the application thereof to any person or circumstance shall to any extent be invalid or unenforceable, the remainder of this Amendment or the application of such term or provision to person or circumstances other than those as to which it is held invalid or unenforceable shall not be affected thereby and each term and provision of this Amendment shall be valid and enforceable to the fullest extent permitted by law.
- 6. **DEFINITIONS.** Capitalized terms used but not defined herein shall have the meaning ascribed to them under the Agreement.
- 7. **REMAINING PROVISIONS.** The remaining provisions of the Agreement not amended by this Amendment shall remain in full force and effect.
