Dear Mr. Salamey,

Washtenaw County wishes to amend the contract with your agency. Corporation Counsel has indicated that this amendment could be accomplished by a letter signed by both of us. If this amendment is agreeable to you, please sign and return all copies of this letter. You will receive an executed copy of this letter upon completion.

Accordingly, I hereby amend the Service Contract between Washtenaw County and Wall Street Towing dated March 1, 2020 as follows:

Amend 11.2 PERMISSIBLE FEES to extend the contract as follows:

“Charges – Please refer to the Washtenaw County Sheriff’s Office Maximum Towing Fees chart (Appendix #4 WCSO Fee Structure 2023 Increases). Note: 2024 Towing Fees Increase will be determined later.

Amend ARTICLE I – TERM to extend the contract as follows:

“This contract shall be in full force and effect for the term of two 1-year terms commencing March 1, 2023, and terminating on February 28, 2025.”

All other terms and conditions remain the same as in the original contract, subsequent amendments and any applicable RFP/RFQ.
