AMENDMENT TO SERVICE CONTRACT Canteen Corrections

This AMENDMENT TO SERVICE CONTRACT ("Amendment") is effective as of March 13, 2022, by the COUNTY OF WASHTENAW, a municipal corporation, with offices located in the County Administration Building, 220 North Main Street, Ann Arbor, Michigan 48107 ("County") and Continental Café, LLC DBA Canteen Corrections, located at 35710 Mound Road, Sterling Heights, MI 48310 ("Contractor")

WHEREAS, the County and Contractor entered into a Service Contract dated July 1, 2020 ("Contract") and an Extension to Service Contract dated November 20, 2020 ("Extension") which outlined the terms and obligations for providing services to the County, and

WHEREAS, the County and Contractor desire to modify terms of the Contract and Extension by way of this Amendment

In consideration of the promises set forth below, the parties mutually agree as follows

The Inmate Meal Pricing Matrix set forth <u>Article II – Compensation</u> in the Contract and revised by that correspondence dated August 23, 2021 addressing the 2021-2022 CPI pricing increase is updated as follows
