Washtenaw County wishes to amend the contract with your agency. Corporation Counsel has indicated that this amendment could be accomplished by a letter signed by both of us. Accordingly, I hereby amend the Service Contract between Washtenaw County and Novx Systems Corp., dated October 1, 2021, as follows:

Amend ARTICLE II – COMPENSATION to extend the contract as follows:


Upon completion of the above services and submission of invoices, the County will pay the Contractor an amount not to exceed Twenty thousand three hundred ninety-four dollars and zero cents (\$20,394.00) annually for software services.

Amend ARTICLE IV – TERM to extend the contract as follows:


This contract extension begins October 1, 2022, through September 30, 2023, at which time will have the option to extend for an additional year.

All other terms and conditions remain the same as in the original contract, subsequent amendments and any applicable RFP/RFQ.


