Dear Ms Woods,

Washtenaw County wishes to amend the contract with your agency Corporation Counsel has indicated that this amendment could be accomplished by a letter signed by both of us. If this amendment is agreeable to you, please sign and return. You will receive an executed copy of this letter upon completion.

Accordingly, I hereby amend the Service Contract between Washtenaw County and In Season Solutions dated, October 1, 2021, as follows:

### Amend ARTICLE II – Compensation

Upon completion of the services outlined in the Addendum (Attachment A) and submission of invoices the County will pay the Contractor an amount not to exceed Thirty-Three Thousand Seven Hundred Ninety-Two Dollars and zero cents (\$33,792 00) annually.

### Amend ARTICLE IV – TERM to extend the contract as follows:

This contract shall be in full force and effect for the term of one (1) year commencing October 1, 2023, terminating on September 30, 2024.

All other terms and conditions remain the same as in the original contract, subsequent amendments and any applicable RFP/RFQ.
