Order Confirmation Your reservation will not be confirmed until this page is signed and returned

Rental Rates: Delux Tents and Events charges an "Event" rate for their rental equipment, providing the "event" is not for an extended period. Example: Events that are on a Saturday will likely be installed a day or two before the event and picked up a day or two after the event. For a typical event, it is not uncommon for rental equipment to be in the possession of the customer for three to five days. The customer, however, is only charged a one day rental fee - not a three, four or five day rental fee. Long term rentals rates are available upon request for customers who have events that span several days/weeks.

Refunds are not given for unused equipment.

Customer Pick Up Orders: For customers who pick up their orders at one of our warehouses, late fees will be applied to all items that are not returned by the specified due date.

Payment: A non-refundable payment of 10% of your order total is required to make a reservation. Payments must be made in full prior to delivery or customer pickup. If your order is scheduled for delivery, the truck will not be loaded with your items until payment has been made in full. We accept cash, checks, Visa, Mastercard, American Express and Discover. If paying with a check, the check must be received in time to "clear" before the truck is loaded.

Lost or Damaged: The customer is held solely responsible for all equipment rented, from time of delivery or pickup until the equipment is returned. Please ensure all equipment is secured when not in use and kept out of the elements. All equipment lost or damaged will be charged to the customer at full replacement cost.

Delivery Service: Your items will be delivered to the closest point our truck can safely park. Our crew will not deliver equipment inside your home or up or down stairs. If you have rented a tent, we will place the equipment under the tent. If, however, there is a long distance between our delivery truck and the tent installation site, we reserve the right to leave the equipment at your door. All equipment will be neatly stacked upon delivery. We ask that you organize the equipment in the same manner when we return for pickup. The delivery window needs to be a least four hours. Ideally your items will be delivered at least one day prior to your event. Delivery times can not be changed the week of the event.

Equipment Set-Up and Break-Down: The delivery service does not include the set-up or break-down of rental items, with the exception of tents, unless additional installation services have been contracted and specifically itemized on the reservation.

Tent Installation: Delux Tents will only install a canopy if the site is marked for utilities. Delux Tents will call Miss Dig to request this service at your property/install location. It is important we know specifically on your property you are planning to have the tent installed. Miss Dig requires four business days prior to our arrival to mark a property for utilities.

The tent location must be free from low hanging tree limbs, electrical, telephone and cable lines. The location of the tent must be clearly marked. It is best if you mark (roughly mark - does not have to be exact) the four corners of the canopy. If you are planning to be home, it is not necessary to mark the locations. Simply direct us when we arrive. Do Not - under any circumstance - attach anything to the tents or side wall fabric. The homeowner is responsible for clearly marking all underground sprinkler lines. The property owner will be responsible for any repairs to sprinkler lines if the water lines/heads have not been clearly identified.

Safety: Delux Tents and Events will not be liable for injuries or damages caused by fire, rain, hail, sleet, snow, high winds, tornadoes, floods or other disturbances of nature. Understand that tents are temporary structures. Keep safety as an overriding priority of your event. Do not seek shelter from severe weather under a tent. If it is not safe to be outside, move guests inside or under a permanent structure.

Accuracy of Counts: Please count all items on your order upon taking possession. Notify Delux Tents and Events if there are any missing items. The customer is responsible for all item counts on the order and will be charged for any missing, damaged or broken items.

Inspection: The Customer is responsible to notify Delux Tents and Events immediately if any of the rental items are defective.

Replacement of Malfunctioning Equipment: If equipment becomes unsafe or in disrepair as a result of normal use, Customer agrees to discontinue use and notify Delux Tents and Events - who will replace the equipment with similar equipment in good working order, if available.

Order Changes: All orders must be finalized 48 hours prior to delivery.

Hold Harmless: Customer agrees to assume risks of and hold Delux Tents and Events harmless for all loss, damage and injury to property, persons, or otherwise, claimed as a result of this rental agreement and services rendered.

Permits: The customer is responsible for securing any permits necessary or required to host your event. Delux Tents and Events will not pull permits for your event.
