

AGREEMENT BETWEEN THE WASHTENAW COUNTY PARKS & RECREATION  
COMMISSION, WASHTENAW COUNTY AND THE WASHTENAW COUNTY SHERIFF  
TO PERMIT THE COMMISSION TO CONTRACT FOR ONE DEPUTY FOR THE TIME  
PERIOD OF MAY 1, 2020 THROUGH SEPTEMBER 30, 2020 AND MAY 1, 2021  
THROUGH SEPTEMBER 30, 2021

AGREEMENT is made this 20 February 2020 by the Washtenaw County Parks & Recreation Commission, located at 2230 Platt Road, Ann Arbor, Michigan ("Commission"), Washtenaw County, a Michigan Municipal Corporation located at 220 N. Main Street, Ann Arbor, Michigan ("County") and the WASHTENAW COUNTY SHERIFF'S OFFICE located at 2201 Hogback Road, Ann Arbor, Michigan ("Sheriff")

WHEREAS, the Commission currently does not contract with the Sheriff to provide contractual police services;

WHEREAS, the Commission would like to contract for one deputy for the period extending from May 1, 2020 through September 30, 2021; and

WHEREAS, the Commission shall be financially responsible to pay for the services of the deputy for the time that he/she works for the Commission under this Agreement; and

WHEREAS, the deputy will be given assignments as agreed upon by the Commission and Sheriff, thereby enhancing police services for the Commission during the summer months.

WHEREAS, the parties now desire to memorialize this Agreement to writing.

NOW THEREFORE, the parties agree as follows:

ARTICLE I – Assignment of Contractual Deputy

The parties agree that beginning on May 1, 2020 and concluding on September 30, 2020, beginning on May 1, 2021 and concluding on September 30, 2021 one deputy currently assigned to secondary road patrol shall be reassigned to do work for the Commission. Upon expiration of this Agreement, the deputy will be reassigned back to secondary road patrol duties.

ARTICLE II - TERM

This contract shall begin on May 1, 2020 and continue through September 30, 2021.

ARTICLE III –PAYMENT FOR RE-ASSIGNED DEPUTIES

During the term of this Agreement, the parties agree that the Commission shall be responsible to pay the County for the price of the reassigned deputy at the rates established and agreed upon in the police service contracts currently in effect throughout the County. Using these rates, the price of the reassigned deputy for the term of this contract shall be for 2020 \$66,937.50 payable by the Commission as follows: May invoice--\$13,387.50; June invoice--\$13,387.50; July invoice--\$13,387.50; August invoice--\$13,387.50; and September invoice--\$13,387.50. If less hours are worked in a month, a pro-rated amount will be billed based on a per day amount.

Using these rates, the price of the reassigned deputy for the term of this contract shall be for 2021 \$67,941.65 payable by the Commission as follows: May invoice--\$13,588.33; June invoice--\$13,588.33; July invoice--\$13,588.33; August invoice--\$13,588.33; and September invoice--\$13,588.33. If less hours are worked in a month, a pro-rated amount will be billed based on a per day amount.

ARTICLE IV- CHANGES IN SCOPE OR SCHEDULE OR SERVICES

Changes mutually agreed upon by the parties will be incorporated into this Agreement by written amendments signed by all parties.

ARTICLE V - EXTENT OF CONTRACT

The terms of this document represents the entire agreement between the parties on the reassignment of the general fund road patrol deputy to the Commission for the term described in this Agreement and supersedes all prior representations, negotiations or agreements whether written or oral on this matter.
