

Mr. Mayor, Today, I read the November 2008 copy of the "Ann Arbor Area Business Monthly". On page 7, I came across an article entitled "Ann Arbor Ranked Second Worst Roads In State". How in heavens name can the city of Ann Arbor allow its road system to become the 2nd worst out of almost 1,800 communities in this state? I travel on Huron Street each day going to and from work. The portion of Huron/Jackson between Main Street and the intersection of Stadium/Maple is and has been in deplorable shape for quite some time. Last winter I called the "pothole" repair number many times to report poor road conditions along that stretch. I assumed that during the summer steps would be taken to correct those problems. There is one particular dip in the road in front of 709 W. Huron that has been patched repeatedly but never repaired properly. The "Band-Aid" approach to road repairs does not resolve these problems. Having the worst roads is one category in which the city of Ann Arbor does not want to be "#2" in the entire State of Michigan. People, whether living in or just visiting Ann Arbor should not have their motor vehicles or bicycles subjected to such poor road conditions. What is being done to address these problems? Matt, Mike and Mark-RE: 1604 Saunders Crescent Addition Completion Issues

A brief conversation this morning with my contractor, Alan Gardulescu raised some questions, specific to the need to resolve the issues surrounding the completion of my project, which now rests on the handicap access ramp, the front roof line and decking that will ultimately be allowed.

The plans on file were submitted after removing the ramp, roof and decking by simply scribbling out those structures, and so, they depict the original plan. Once it is determined what to submit as revision plans for review, what happens at that point?

1) If we resubmit the original drawings as our revision (no scribbling out the ramp, roof and decking), would they now go through? OR

2) If we have to resubmit the original drawings without the roof, will they go through? AND

3) Once we understand WHAT to submit, in order to complete my project's inclusion of the handicap access ramp and what decking/roof will be allowed, *can whomever it is who is the reviewer commit to a speedy clearance of the plan?* We can likely resubmit the revision immediately, since it is simply a matter of resubmitting or resubmitting an additional edited version of the original plan. Time is of the essence, with the extreme weather coming.

Dear Matt and Mike,

I am bringing together you two and the folks who are cc'd in this email to facilitate some updating, advisement and reliable information leading to the completion of my home addition.

If you recall, my addition's plan needed modification to be accepatble, due to existing set back averaging addendum to the City's 25 ft. set back rule. In mid-May of this year, at the Planning Dept's advice, my building plan was modified to exclude the 6X6 porch and roof over it and the handicap access ramp, until City Council's rescinding of the addendum/ae "in the next month or two" (permit desk staff), which would have been June-July, 2008. Since Council has tabled this repeatedly and my most recent calls go unanswered, I am again attempting to accomplish closure on the issues needing addressing and complete the building of my addition, originally projected to be completed by August-end, 2008.

Below is the compilation of the emailing which I initiated mid-September at the suggestion of the Building Department and of which I am aware/have seen.

Also below, in the first 'entry', is my transcript of the thoughtful 9/23/08 phone message Mike left for me as a response to Mayor Hieftje's good efforts to respond to my problem/emailing. While parts of Mike's message are reassuring, its tenor is not consistent nor clear. On the one hand, everyone has been urged to proceed with (my addition issues), yet my 2 calls left as messages to Mark Lloyd (one on a machine; one w/office staff) have gone unanswered and six more weeks have passed. I still need a handicap access ramp, am counting on a resolution to incorparate an esthetic front to my small '50's subdivision home and to finish my home's addition "before the snow flies".

To meet with whomever it is/will be, along with my contractor, Alan Gardulescu, to work out the possibilities as they exist, without further feeling discrimiated against due to my unwillingness to "remeasure, resubmit" set back measurements reflecting conjured - but acceptable - set back distances.
 Update on the timeline for Council's dealing w/averaging of existing front set backs. This addendum is generally not heralded by the Planning and Development staff in my limited contact and is soooo not universally applicable - especially, as Matt can report, not on a curved street, as in my instance.
 Email/phone number contact information for Carsten Hohnke (I think he's now someone for me to contact, too?).

Thank you for your time and efforts. Please advise. Best regards, Yael Ganet

9/23/08 phone msg transcription to me from Mike Anglin:

"This is ... Mike Anglin.

I read all the communication back and forth on the set backs of the house and the front porch and

everything being done. I just wanted to see how you are proceeding the building department seems to be very much on top of this and I really believe that further discussion with them is in order so that you can continue with your project. I wish you good luck if there's something I can help you out with give me a call.

But is seems to me that with a competent builder and with your plans and working with the building department from everything I have read... Mark Lloyd was nice enough to send enough emails back and forth about it so a number of city staff are more than willing to help you out to complete your project. So if there's anything I can do you can give me a call at 741-9786, or send us another email. But I think "emails have gone around to the mayor; Chris is aware of it, Chris Easthope; I'm aware of it; Carston Hohnke: he's not on City Council yet, as the mayor said. The mayor is quite aware of it and has urged everyone to proceed with it and to help you out as much as possible.

So, I think you, by working with city staff, you'll be on the right path. I wouldn't wait for any ordinance changes because that could take a while. Whatever they advise you to do now under the present circumstances you should do. Do not wait for something in the future that may or may not change. Hard to say. I don't know that and no one knows when it will finally come to Council re: change of ordinance plans.

I hope you have your project plan and that when you're finally done you are pleased with it and that the planning process "etc." continues.

That's the best I understand from what I know. Thank you. Bye."

Mayor Hieftje, Councilmembers Easthope and Anglin-

I appreciate your attention and efforts at serving our city. With this reply, I include/cc my contractor, The Renewal Company - Alan Gardulescu - well-known for quality work in our area.

I will add some reflection, after sitting at the Council's meeting last night. I heard Councilmembers acknowledge the Code(s) being "impossible for anyone to follow". I witnessed how trivial a matter it was to table code amendments/repeals. I am left wondering when the issue WON'T be tabled...and others, like me, will continue to submit plans with a sense of certainty that 'all is well' since the city's 25' Set Back Code is followed - all to be surprised with their plans' rejection and options of "remeasure, resubmit" - wink; change the plan to shortchanging the set back to reflect their neighbors' average without regard to the specific neighborhood's layout/etc; apply for an exorbitantly-priced variance request with the good ppossibility of the request being tabled or denied - all while thousands and thousands of their dollars are held in questionable status.

As many others in our town, I grew up in Ann Arbor and live in my childhood home, looking to improve and grow old in my neighborhood - not blight it w/a small and simple addition's incompletion for months at a time. *Mr. Gardulescu and I have followed advice provided by our Planning Department throughout the slowed progress of my project.* Most recently, I have been encouraged to raise this issue (of continuing the simply tabling of amendments and revisions - including Set Back Averaging) which, as I understand it, would reorganize the code(s) to facilitate clear understanding while restoring Ann Arbor's residential single family home owners' full and rightful property use.

Thank you again for your attention, interest and any subsequent involvement in 'untabling' the mired mess of our building code.

Again, I appreciate your reply and await further discourse.

#### Mayor Hieftje-

1) OK - thank you for replying and for the council member info. I am taking the liberty of emailing them w/the CC of this message.

2) My home's addition project is designed to streamline the footprint of an ADA handicap entry ramp to blend w/a small porch level and barrier-free at the ramps point of entry, extending almost 5' to the corner-edge of the addition. The plans were submitted in April/May.

In early June, when we hadn't heard back about the plans, I called the Building Permit Dept. (6/3/08) and Theresa "checked on progress". She located it "in with Roland" of the grading department and "" ventured to "put it on (Roland's) chair", with the request to respond to my inquiry on its progress. Roland called back within the next few days to inform me this original architectural plan was <u>not</u> accepted.

My contractor and I visited the Building Permit desk where we were informed by Chris Chang that the 25' set back was no longer the rule. Mr. Chang encouraged me to consider that perhaps I had 'mismeasured', even though I made it clear that I had indeed measured correctly. We were advised then, and I, again, on more than two occasions, that perhaps I had 'mismeasured' and that if I "remeasured, resubmitted or revised to a 'corrected' set of numbers (my set back average = 27 1/2')", that "...it would be put right through". When my 'brows rose' at this encouragement and I stated I couldn't take part in falsifying documentation, I was informed that "the department doesn't have time to measure (nor) remeasure" for set backs" (dimensions).

### "BACK TO 25" ACCESS":

Further, we were advised that this addended 25' set back (the averaging of one's 4 adjacent neighbors' supercedes the city's universal residential rule of 25') would be voted on and most certainly would be passed and rescinded in June.

On considering this, I decided to go ahead w/my project. The plan for the 25' set back, would ultimately be re-entered into the plan as a revision, once the rule was rescinded. So, we 'revised' the plan by simply crossing out the porch - for the time being.

My addition was started. The Set Back "rescinding" was tabled to July, when, again, I was advised, it would most certainly be passed. In July, it was again tabled.

I made a multitude of calls in an attempt to understand the issues surrounding the rescinding process, which began w/Mr. Chang's suggestion to contact Jill St John, who stated she would "have to call (me) back."

Additional phoning (6/10 - 7/31) failed to produce any 'real' info on the status of this matter, aside from the updates I received when I would contact the Permit Desk. As well, many calls were met with messages of "mailbox full"; "being checked for trouble"; "phone tag via messages"; no response). I finally reached Site Inspector Roland on 8/6/08, who referred me back to Ms. St. John.

I ultimately succeeded in again reaching Ms. St. John on 8/21/08, who then informed me the "averaging changes (were) part of (numerous) area and height changes being proposed, many of which would be

rescinded." However, the "Set Back Averaging" points were "pulled out of the 'package' of code changes" to be "formally checked with Senior Planner(s)."

Matt Kowalski is the Planner who is now handling or heading the process: "Set Back Averaging", who reports its status is "back to ordinance planning/revision" process.

Matt states while the code's perametersparameterse the contractor's or architect's responsibility", the changes are "buried (in the text) where no one sees it."

Speaking w/Matt (9/15/08) after September's first City Council meeting, he stated any "changes (affecting) single family (residences would not be) on October's docket". He has since emailed me the code: Chapter 55, Section 5:57.

I am struggling to understand - and navigate -the whole mess, while feeling greatly discriminated against for not being one of the many who are encouraged to and follow through w/"remeasuring, resubmitting (RR)" my numbers and "having it put right through". I need some voice on the Council. Seems the change was initiated by folks in Burns Park . I don't live there and there are folks in my late-'50's subdivision who have added porches using the "RR"-wink method or who succeeded with the exhorbitanexorbitantky - process of Applying for a Variance. No way to check how many folks have 'fudged' the numbers - the system doesn't do that...although, it would be, I'm sure, revealing that the current Set Back Averaging is mostly scoffed at when there are "only a foot or two" at point.

Advice? Support? Thanks again. Yael Ganet



This memo outlines (1) a summary of your performance for FY 2008; (2) your goals for FY 2009; and (3) a summary of changes to your employment agreement that were approved by the City Council on October 20, 2008. The recommendations regarding your compensation were approved by the City Council on October 20, 2008. Your FY 2009 goals were approved by the City Council Administration Committee ("Committee"). All these recommendations were based on your 2007-2008 self-evaluation and the input of City Council members who completed evaluations of your performance.

### A. Summary of FY 2008 performance

You achieved many of your goals identified for FY 2008. Councilmembers praised you for your leadership on the City Budget which is particularly important during this challenging economic environment. Councilmembers believe that economic development must be one of your top priorities for FY 2009. That is reflected in the goals outlined in Section (B) of this memo. Councilmembers also urge you to take more pro-active steps to communicate effectively and frequently with the public and with Councilmembers, particularly regarding projects in which the Councilmembers have a known interest.

### B. Goals for FY 2009

Your goals for FY 2009 are as follows:

- 1. City Services
  - → Safety Services: Continue planning for a consolidated emergency services dispatch system
  - → Community Services: Develop a plan with community input for the construction of at least 60 new units of housing for very low-income individuals
  - → Public Services: Adhere to the timeline for the Municipal Center project
  - → Financial Services: (1) Develop a two-year budget plan (for FY 2010 and 2011) that reflects the long-term goals that will be established by the City Council in late 2008/early 2009; and (2) develop for Council action a comprehensive economic development plan for the City of Ann Arbor.

- 2. Other
  - $\rightarrow$  Modify the City's website to make it even more user-friendly for the public
  - → Develop a plan for review by the Committee to ensure prompt follow-up with Councilmembers and community leaders on their initiatives
  - $\rightarrow$  Begin succession planning for the Administrator and Area Administrators

### C. Compensation Changes for FY 2008

The Committee did not recommend any increases in base pay for the Administrator, Attorney, or Area Administrators. Instead, such individuals should be awarded lump-sum payments, based on performance, to ensure consistency with collective bargaining agreements for represented employees, provide long-term financial savings for the City, and recognize the challenging economic climate facing the City and Ann Arbor taxpayers. Accordingly, the Administrator's employment agreement was modified as follows by the City Council on October 20, 2008:

- On or before December 1, 2008, the City Administrator shall receive a one-time lump-sum payment representing 2.5% of base pay.
- On or before June 30, 2009, the Administrator may, at his discretion, cash out up to 150 hours of any accumulated vacation, sick, or personal time.

According to staff figures, we guesstimate that we p/u 10,500 tons over an 8 week period. If we go to bag p/u, and we only p/u, say, 8,000 tons. If 8,000 tons weighs 16 million pounds and one bag weighs 25 lbs.(my estimate), that amounts to 640,000 bags (16 million lbs. divided by 25 lbs bags=640,000) or if we p/u 9,000 tons of bags = 720,000 bags.

1. According to the above-mentioned scenario, how many tons of leaves per day/per week will be removed?

2. How many collection trucks will be used per day?

3. What weight/# of bags/# of trucks scenario was used to arrive at \$140,000.00 program cost once leaf p/u is eliminated?

Regarding leaves that fall directly into the street and aren't bagged: Staff estimates about 12%. If its 12% of the 10,500 tons we would normally p/u assuming all lawn and street trees are raked together, that amounts to about 1,200 tons of leaves that the city will still be responsible for getting out of the street: According to a recent memo, I understand that:

"our first plan for leaf removal is regular street sweeping. In some areas this may require 1-2 sweepings per week during the peak of the season or after a heavy rain. These costs were factored into the budget and that additional sweeping is the bulk of the budget submittal for leaf removal."

Over an eight week period, that is approximately 150 tons per week or 30 tons per day on a 5day work week. ( 1,200 tons divided by 8 weeks)

1. How many tons of leaves will 1-2 sweepings per week capture? How did you arrive at that number? (i.e..# of sweepers, capacity of sweepers, number of trucks).

2. As i understand how street sweepers work, some of the leaves will be ground up and pushed down the drain eventually. Is that correct?

Whereas, The Ann Arbor Tally Hall Condominium Association owns and maintains common area in the Ann Arbor Tally Hall Condominium ("Condominium"), located between Liberty and Washington Streets, in the City of Ann Arbor, Washtenaw County, State of Michigan, and more fully described as follows:

Ann Arbor Tally Hall Condominium, according to the Master Deed thereof, as recorded in Liber 2116, Page 810, Washtenaw County Records, designated as Washtenaw County Condominium Subdivision Plan No. 60.

Whereas, The City of Ann Arbor and McKinley, through MTC 2, LLC, or another affiliated ownership entity ("McKinley"), are the only members of the Ann Arbor Tally Hall Condominium Association through their ownership of units in the Condominium, and are co-owners of the general common area in the condominium;

Whereas, On January 7, 2007, City Council approved the McKinley Towne Centre - Liberty Retail PUD Site Plan and Development Agreement (R-08-008), subject to McKinley entering into an agreement with the City for the sale of the general common area necessary to complete the development;

Whereas, McKinley has decided not to pursue the McKinley Towne Centre -Liberty Retail PUD Site Plan at this time, but still requires the sale of some of the general common area to redevelop parts of the site;

Whereas, McKinley, desires to purchase 5,913 3,042 square feet of common area in the Condominium from the City, as shown on the attached diagrams, for the purpose of completing the McKinley Towne Centre - Liberty Town Center development;

Whereas, the City and McKinley have agreed that McKinley will pay the City \$102,896 200,000 for the common area;

Whereas, the Michigan Home Rule Cities Act and the Ann Arbor City Charter, pursuant to Chapter 3, § 3.1, grant the City the power to sell or dispose of real property; and

Whereas, City Council has determined that the property is no longer needed for public purposes;
