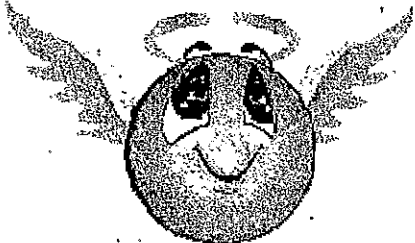

I have left phone messages with both of you, although we have never connected in person regarding the issue at hand. I would like to urge the two of you to continue to monitor the issues on Ridgemor Drive and would urge you to keep us informed. We have been unable to get the City Attorney's office to respond to our inquiries about the current status. Our recent discovery (that he may also be over the rear setback) has the neighbors VERY concerned ... once again. Yesterday, it appears, Dan Williams moved out of 9 Ridgemor. The surveyors were at 4 Ridgemor nearly all day Saturday, a holiday weekend. Obviously there is some urgent need on Dan's part to clear this up. We have been unable to learn what the new survey showed and we are concerned that we may find out too late to respond.

This has been a very long process for all of us without any satisfaction that the ordinances the city has adopted, to protect other citizens, will ever be upheld. The neighbors followed the rules - we showed up and spoke at the ZBA meeting, even questioned that we thought the house was within the 25' setback erroneously approved by the City, let alone the 33' setback he should have used (and we were right!). The ZBA rightly denied the request for a variance. The builder (Dan Williams) took the city to court, but the judge ruled that his plans were erroneously approved by the city at 25' so he could go ahead and use the 25' setback. The fact that the house is actually 21.5' from the right of way, clearly 3 1/2 feet inside the minimum setback was never fully addressed. The impact to our neighborhood is great, especially because there are two more lots (recently for sale) which will be built upon some day. Those lots will use the 21.5 foot front setback when averaging the front setback for the new homes; bringing them closer to the street.

Instead of appealing the judge's decision, the City agreed to a fine of \$8,500 (1% of the sale price of the house); truly not in the best interest of the neighborhood. While the City Attorney's Office has made it clear to us that he's "not happy with the judge's decision, but he needs to run his office" (basically telling us to stay out of it), he clearly did not perform. Look at the result. If the City truly wanted to enforce the ordinance to the benefit of neighborhood, this should have been appealed. The City Attorney will tell Council that winning the appeal wasn't guaranteed and he was worried about setting a precedent that would work against the city in the future. I

don't know of anything guaranteed in a court and by doing nothing, the precedent is set—the City is unwilling to vigorously pursue enforcement of its ordinances and ZBA rulings! Clearly, the City Attorney wanted this case off his desk, so he recommended to Council that it settle for a ridiculous amount! At a minimum, the City should have not settled for anything less than half the cost to modify the house (In the eyes of the judge, both parties were at fault—so why not split it? While the builder knew of the problem early on (because the City contacted him), the builder kept building as fast as he could. He made a bad situation worse, but was never held accountable.)

This has been handled poorly from the start and, without the neighbors being involved, we are certain that most of it would have been swept under the rug by now. We are extremely disappointed in the City's inability to uphold its ordinance, the closed nature of making the deal, the reluctance to take the case to the next court, and are extremely disappointed that we had to do so much leg work in order to get anyone's attention. We felt that appearing before Zoning Board should have been enough. This hearing and the testimony gave the City Attorney everything he needed to win this case. The ZBA did the right thing—the City Attorney's Office did not get results; it gave up. I have now been to Planning to get copies of surveys and building plans, to the court to find out what the fine was and get copies of the circuit court transcript, and made numerous phone calls to try to find out what was going on. We certainly would have contacted you earlier if we knew this is how it was going to be handled and we needed help from city council members in order to be heard. But, frankly, the closed nature of part of the process made this impossible to do.

Please, please, please keep us informed and do not let this builder (and any other builder in the city) get away with this blatant disregard for city ordinances.

Dear Sabra and Ron,

My husband and I appreciate your replies and your encouragement.

It is very difficult to get information about this situation in a timely manner and to know how to most effectively inform the Council of our concerns. In fact, sometimes it appears things have been done "behind closed doors" and made it impossible to address what we experience as very important issues, especially in a timely fashion.

Please let us know of pertinent information or indicate if there are things we could be doing that we haven't. Obviously we feel we haven't been treated fairly and that we deserve your support.

The WHOLE Council should know that only 8 families live on Ridgemor Drive. The disputed new house--4 Ridgemor-- is at the entrance of Ridgemor Drive. Two of the 8 families are deeply involved in the development of 4 Ridgemor: the Williams and the Staples. Of the remaining 6 families, 5 have written to you and/or called you, many of them multiple times to protest what has happened. The remaining family has made it clear (in part because Dan Williams misquoted what they said) that they do not support that Dan Williams has violated city ordinances. Rather, they wish to remain neutral.

So the WHOLE Council needs to notice that of the families who are NOT involved in the development of property on Ridgemor, NONE of them support the violation of city ordinances which has occurred with the construction of 4 Ridgemor.

First, it is odd that even one long-term resident family of Ridgemor has to protest that ordinances designed to protect them were not observed. This enforcement should have occurred automatically.

Second, it is disappointing that the Council apparently will only pay attention to a violation if all the citizens affected by a violation protest it.

Third, because now ALL of the citizens who are affected by the violations have protested or made it clear they do not support the violations, it is my fervent hope the Council and appropriate city governance committees will respond to our urgent appeal and take the responsibility to help the 6 long-term Ridgemor families immediately.

- DELETE from 9:42(1): "(as defined below in subsection 3 (i))"
- Add to 9:42(1) : "For purposes of this section only, adjacent property means all parcels of property, the principal use of which is for a single-family dwelling or two-family dwelling and with which the applicant's property comes into contact at one or more points, except for parcels that are legally adjacent to but are in fact separated from the applicant's property by a public or private street. Permits expire and become invalid five (5) years after the date of issuance. A person who wishes to continue keeping chickens shall have obtained a new permit on or before the expiration date of the previous permit. Application for a new permit shall be pursuant to the procedures and requirements that are applicable at the time the person applies for a new permit."

ANIMALS (REGARDING CHICKENS)

AN ORDINANCE TO ADD A NEW SECTION 9:42 TO AND AMEND SECTIONS 9:38, 9:45, AND 9:52 OF CHAPTER 107 (ANIMALS) OF TITLE IX OF THE CODE OF THE CITY OF ANN ARBOR

The City of Ann Arbor Ordains:

Section 1. That Section 9:38 of Chapter 107 of Title IX of the Code of the City of Ann Arbor be amended to read as follows:

9:38. Domestic animals and fowl.

- (1) No person shall keep or house any animals or domestic fowl within the city except dogs, cats, rabbits, canaries or small animals commonly

classified as pets which are customarily kept or housed inside dwellings as household pets.

- (2) Subsection (1) shall not apply to animals or fowl that are kept or housed at city park facilities for exhibition.
- (3) Subsection (1) shall not apply to the keeping of chickens in compliance with all requirements of Section 9:42.
- (4) Nothing in this Chapter shall prohibit the City or a third party from bringing a nuisance action based on the keeping of animals.

Section 2. That Section 9:42 be added to Chapter 107 of Title IX of the Code of the City of Ann Arbor to read as follows:

9:42. Keeping of Chickens.

(1) Any person who keeps chickens in the City of Ann Arbor shall obtain a permit from the City prior to acquiring the chickens. No permit shall be issued to a person, by the City, and no chickens shall be allowed to be kept unless the owners of all the adjacent properties **DELETE: (as defined below in subsection 3 (j))** consent in writing to the permit and this consent is presented along with an application for a permit. Written statements waiving the distance requirement in subsection (3) below shall also be submitted at the time of application and become a part of the permit if issued. Application shall be made to the City Clerk and the fee for the permit shall be as determined by Council resolution. **For purposes of this section only, adjacent property means all parcels of property, the principal use of which is for a single-family dwelling or two-family dwelling and with which the applicant's property comes into contact at one or more points, except for parcels that are legally adjacent to but are in fact separated from the applicant's property by a public or private street. Permits expire and become invalid five (5) years after the date of issuance. A person who wishes to continue keeping chickens shall have obtained a**

new permit on or before the expiration date of the previous permit. Application for a new permit shall be pursuant to the procedures and requirements that are applicable at the time the person applies for a new permit.

- (2) Notwithstanding the issuance of a permit by the City, private restrictions on the use of property shall remain enforceable and take precedence over a permit. Private restrictions include but are not limited to deed restrictions, condominium master deed restrictions, neighborhood association by-laws, and covenant deeds. A permit issued to a person whose property is subject to private restrictions that prohibit the keeping of chickens is void. The interpretation and enforcement of the private restriction is the sole responsibility of the private parties involved.
- (3) A person who keeps or houses chickens on his or her property shall comply with all of the following requirements:
- a. Have been issued the permit required under subsection (1) of this section.
 - b. Keep no more than four (4) chickens.
 - c. The principal use of the person's property is for a single-family dwelling or two-family dwelling.
 - d. No person shall keep any rooster.
 - e. No person shall slaughter any chickens.
 - f. The chickens shall be provided with a covered enclosure and must be kept in the covered enclosure or a fenced enclosure at all times. Fenced enclosures are subject to all provisions of Chapter 104 (Fences).
 - g. A person shall not keep chickens in any location on the property other than in the backyard. For purposes of this section, "backyard" means that portion of a lot enclosed by the property's rear lot line and the side lot lines to the points where the side lot lines intersect with an imaginary line established by the rear of the single-family or two family structure and extending to the side lot lines.
 - h. No covered enclosure or fenced enclosure shall be located closer than ten (10) feet to any property line of an adjacent property;
 - i. All enclosures for the keeping of chickens shall be so constructed or repaired as to prevent rats, mice, or other rodents from being harbored underneath, within, or within the walls of the enclosure. A covered enclosure or fenced enclosure shall not be located closer than forty (40) feet to any residential structure on an adjacent

property provided, however, this requirement can be waived as follows:

- (i) If the principal use of applicant's property is for a single-family dwelling, to obtain such a waiver the applicant shall present at the time of applying for a permit the written statements of all adjacent landowners that there is no objection to the issuance of the permit.
- (ii) If the principal use of the applicant's property is for a two-family dwelling, to obtain such a waiver the applicant shall present at the time of applying for a permit the written statements of all adjacent landowners and of the occupants of the other dwelling stating that there is no objection to the issuance of the permit.

DELETE j. For purposes of this section, adjacent property means all parcels of property that the applicant's property comes into contact with at one or more points.

- k. All enclosures for the keeping of chickens shall be so constructed or repaired as to prevent rats, mice, or other rodents from being harbored underneath, within, or within the walls of the enclosure.
- l. All feed and other items associated with the keeping of chickens that are likely to attract or to become infested with or infected by rats, mice, or other rodents shall be protected so as to prevent rats, mice, or other rodents from gaining access to or coming into contact with them.

l. If the above requirements are not complied with, the City may revoke any permit granted under this section and/or initiate prosecution for a civil infraction violation.

- (4) A person who has been issued a permit shall submit it for examination upon demand by any police officer or code enforcement officer.

Section 3. That Section 9:45 of Chapter 107 of Title IX of the Code of the City of Ann Arbor be amended to read as follows:

9:45. Definitions.

For the purpose of this chapter, the following terms shall have the following meanings respectively designated for each:

- (1) *Animal control officer.* Any city police officer or such other persons as the administrator may designate provided that such persons meet the qualifications specified by Act 339, Public Acts of 1919, as amended.
- (2) *Dangerous animal.* An animal which has bitten a person so as to draw blood or caused a person broken bones or which has repeatedly attacked, chased or menaced any person or damaged the property (including animals) of persons other than the owner. An animal shall not be considered dangerous solely because it has bitten or attacked a person or any animal attacking its owner or its owner's family nor shall an animal be considered dangerous if it bites or injures a person who has, without justification, provoked it by attacking it or its young.
- (3) *Dog play area regulation.* A regulation that provides rules and requirements for the use of designated dog play areas by dogs and dog owners. The Community Services Administrator or designee may make and issue dog play area regulations, which shall be effective upon approval by City Council and filing with the City Clerk.
- (4) *Noise nuisance.* Barking, howling, meowing, squawking or making other sounds, frequently or for a continued duration, which annoys, endangers, injures or disturbs a person of normal sensitivities on premises other than that occupied by the owner of the animal. After 10:00 p.m. and before 7:00 a.m., animal noises audible beyond the property line of the property where the animal is located are presumed to be an annoyance and disturbance and are presumed to constitute a noise nuisance.
- (5) *Sanitation nuisance.* Unsanitary conditions resulting from animal droppings, food waste, debris, or any other thing to cause vermin infestation, odors, or disease hazards.
- (6) *Own.* To have possession or a right of property in an animal or to permit a dog or cat to remain on or about one's premises 5 days or more.
- (7) *Under reasonable control.* A dog which is:
 - (a) Secured by a leash held by the owner or the owner's agent;
 - (b) Secured by a leash which is attached to a stationary object and attended by the owner or the owner's agent; or
 - (c) On the premises of the owner or confined in a vehicle.

- (d) On the premises of a dog play area as designated by the Community Services Area Administrator or designee and upon approval by City Council.
- (8) *Vicious animal.* An animal which:
 - (a) Has killed a person or caused a person serious bodily injury, including, but not limited to, injuries resulting in hospital confinement or reconstructive surgery.
 - (b) Is owned, possessed, harbored or trained for the purpose of animal fighting.
 - (c) Repeatedly bites or in any way injures people.

Section 4. That Section 9:52 of Chapter 107 of Title IX of the Code of the City of Ann Arbor be amended to read as follows:

9:52. Penalty.

Violation of this chapter shall be punished by a fine of not less than \$25.00 nor more than \$500.00. For the second and subsequent violations of this chapter within a 2-year period, the fine shall not be less than \$50.00 nor more than \$500.00. In addition, violation of section 9:35 and subsection 9:47(6)(7) may be punished by imprisonment for up to 90 days. However, violation of 9:47(1), (2), (3), (4) and (5) shall be punishable by only a civil fine of not less than \$25.00 nor more than \$500.00 for a first offense and for a second offense not less than \$50.00 nor more than \$500.00.

Section 5. That this Ordinance shall take effect on the tenth day following legal publication.
